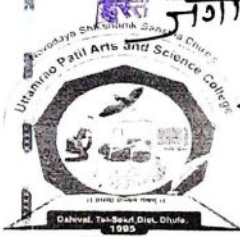

The parties assume full responsibility for their performance under the terms of this Memorandum.

Any notice or communication required or permitted under this Memorandum shall be sufficiently given if delivered in person or by certified mail.

ASSIGNMENT



Neither party to this Memorandum of Understanding may assign or transfer the responsibilities or agreement made herein without the prior written consent of the non-assigning party, which approval shall not be unreasonably withheld.
